2. The financial upgradation under the MACPS is purely on personal basis in the immediate higher Grade Pay and shall not amount to actual/functional promotion of the employees concerned. No stepping up of pay in the pay band or grade pay would be admissible with regard to junior getting more pay than the senior on account of pay fixation under MACP Scheme. The seniority of the above officials in the respective grade will remain unchanged.

3. The pay and date of increment would be fixed in accordance with the clarification No.2 of the Department Expenditure's O.M. No.1/1/2008-IC dated 13.09.2008. The above mentioned employees may exercise their option under FR 22(1)(a)(1) to get their pay fixed on financial upgradation under MACPS, within one month of issue of this order.

4. The financial upgradation is subject to audit verification and recovery if any, at any stage.
