3. The option once exercised shall be final. It is stipulated that if the intimation regarding option is not received within a period of three months from the date of publication of the Central Civil Services (Revised Pay) Rules, 2016 i.e. by 28.10.2016, the Government Servant shall be deemed to have elected to be governed by the revised scale of pay with effect on and from 1st January, 2016.
